APPLICATION PROCESS for INTERNATIONAL STUDENTS

Thank you for your interest in Académie Ste. Cécile International School. In order to expedite the application process, it is very important that you follow carefully each of the following steps:

Stage #1:

Please Submit:

- the completed "Application for Admission" form;
- the non-refundable fee of \$300.00 (Canadian);
- your last year's report card as well as this year's most current report card and
- the "Confidential Reference" form.

Stage #2:

When the school receives and reviews all of the above documents, a decision in writing will be sent to you.

(a) If the school accepts your application, you will also be sent the following documents which you should read and complete as soon as possible:

- the "Registration" forms;
- the "Medical" form requiring, by law, that all students have received the appropriate immunization and testing prior to entering school;
- an invoice requiring payment in the total amount which has been calculated according to the details of your chosen programme:

For either option, please send the completed "Payment of Fees" form along with the funds. Please be sure to include the student's name on all transfers. In the case of electronic transfers, parents are responsible for all domestic and international service charges incurred.

Please note: This money will be held in trust to the credit of the student. Once a Student Authorization and Visa are granted to the student applicant, no part of any amount paid to the school will be refunded. If a Student Authorization and a Visa are not granted to the student applicant, then, all amounts except for the application fee will be refunded.

(b) If the school does not accept your application, you will be encouraged to re-apply at a later date. The application fee will not be refunded.

Stage #3:

(a) When the school receives and reviews all of the completed documents as outlined in Stage #2 and when the school has received and deposited the required payment, you will receive a **"Confirmation of Acceptance"** letter stating that you have thus far fulfilled all of the registration requirements.

(b) Since you must complete all visa arrangements **prior** to your arrival in Canada, you should **promptly** take the "Confirmation of Acceptance" letter to the Canadian Consulate General Office located nearest to you and make application for a Student Authorization and Visa in order to come and study in Canada at the Académie Ste. Cécile International School. You are responsible to pay for all expenses incurred in this process.

(c) When you procure your Student Authorization and Visa, kindly notify the school as soon as possible by sending us a copy of these documents. You should then make appropriate travel arrangements.

(d) Again, please note: Once a Student Authorization and a Visa are granted to the student applicant, no part of any amount paid to the school will be refunded. Only when a Student Authorization and Visa are not granted to the student applicant, will all amounts (except for the application fee) be refunded.
